



Welcome to Formentera

Properties owned by Revolution Resources II, LLC, Revolution II NPI Holding Company, LLC, Nosley Scoop, LLC, and Nosley Assets, LLC (collectively, “**Revolution**”) in Canadian, Caddo, Garfield, Grady, Kingfisher, and McClain County, in which you own an interest have been purchased and are now operated by Formentera Operations LLC (“**Formentera**”).

As part of this transaction, Formentera is assuming activities beginning in September 2023, regarding the handling, processing, and payment of revenue related to the wells previously operated by Revolution. For September’s Revenue Distribution, you will receive payment from Formentera for August 2023 oil and a separate payment from Revolution for July 2023 oil and gas. Formentera will begin Revenue Distribution on September 27th, 2023, and you should expect to receive your paper check by the first week of the month following distribution. Again, this is for August 2023 oil only. For the accounting month of October 2023, you will begin to receive payment for September 2023 oil and August 2023 gas.

Formentera has partnered with MineralAnswers, who is leading the way to empower owners with a modern owner portal, where they can access their statements online and update their payment information to Direct Deposit. EnergyLink also gives owners the ability to view statements online - you will need to add Formentera as an operator to gain access to this information.
